	<ul> <li>- \$250.00 will be added to the scholarship if that same student attends one seminar-styled event for the vast majority of the event time (ideally the entire event time). IOW, they cannot show up for lunch and leave; for one seminar out of the 4-6 present that day and leave; we want them there and engaged. Also, our spring social event, nor any other "social-only" event, will not count as attendance towards the seminar-styled events.</li> <li> This would potentially make the total possible scholarship amount \$2,000.00.</li> <li> A motion was made by Jeff Theo, seconded by John English, and passed unanimously. Comments were requested from those not present through e-mail. Missy and Steve L agreed with the decision.</li> </ul>
